PLEASE READ BEFORE SIGNING:

In consideration of **student** being allowed to participate in any way in CADDO PARISH SCHOOL BOARD (RELEASEE), athletics/sports program whether involving team or individual sports and related events and activities, the undersigned acknowledges, appreciates, and agrees that:

1. The risk of injury to student from the activities involved in the program is significant, including the potential for permanent paralysis or death; and while particular rules, equipment, and personal discipline may reduce the risk, the risk of serious injury does exist;
2. The risk of student to have direct or indirect contact with individuals who have been exposed to and or diagnosed with one or more communicable diseases, including but not limited to **COVID-19** or other medical conditions, diseases, or maladies, and/or any mutation or variation thereof, does exist and it is impossible to eliminate the risk that student could become infected through contact with or close proximity to an individual with a communicable disease;

I, for myself, student, and on behalf of our heirs, assigns, personal representatives and next of kin, HEREBY RELEASE AND HOLD HARMLESS CADDO PARISH SCHOOL BOARD, its officers, officials, agents and/or employees, other participants, sponsoring agencies, directors, sponsors, advertisers, and, if applicable, owners and lessors of the premises used to conduct the event (collectively, the "Releasees"), WITH RESPECT TO ANY AND ALL INJURY, ILLNESS, DISABILITY, DEATH, or loss or damage to person or property, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE.
